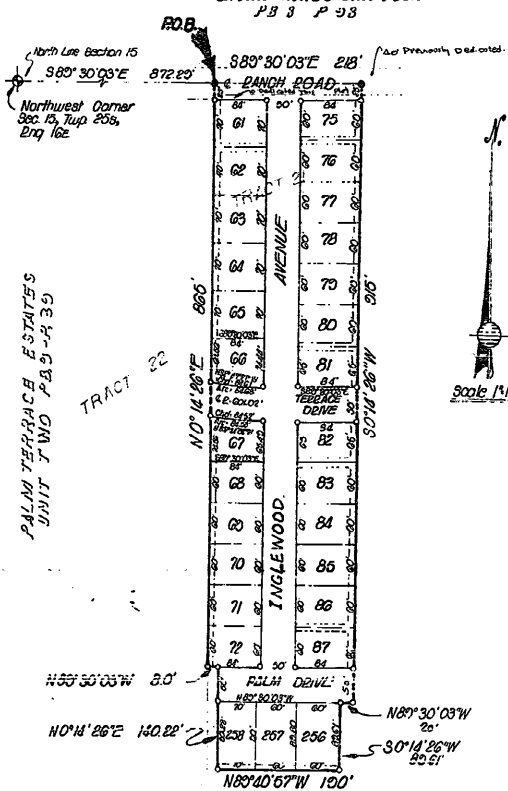


PALM TERRACE ESTATES UNIT THREE
