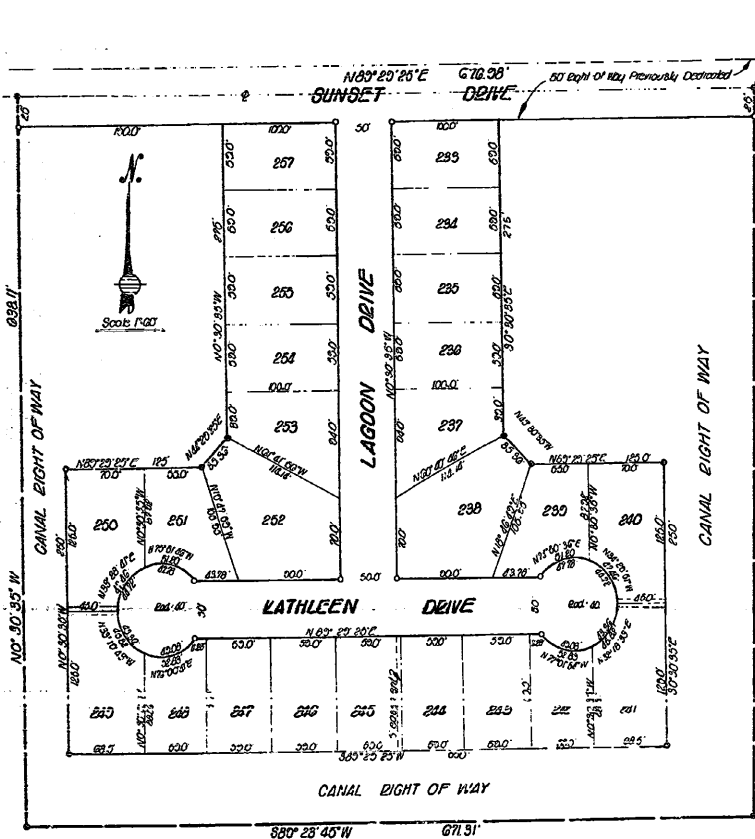


SEA RANCH ON THE GULF FOURTH ADDITION
