



Commence at the Northeast corner of Section 33, Township P 21 S, Range 16 E, Pasco County, Florida, thence run along the East line of said Section 33, 80° 20' 26" E, 1,328.68' to the North line of the South 1/2 of the North 1/2 of said Section 33; thence along said line, 80° 20' 26" W, 2817.60' ft. for a Point of Beginning; thence run due South, 80° 20' 26" E, thence 80° 20' 26" W, 670.98' ft.; thence N 80° 20' 26" W, 621.11' ft.; thence N 80° 20' 26" E, 670.98' ft. to the Point of Beginning.

have caused said land to be divided and subdivided as shown herein and do hereby dedicate to the respective use of the public, all roads, streets, alleys and other rights of way and all parts and reservations upon and oil easements for utilities, drainage and other purposes and for all purposes incident thereto as shown and depicted herein, reserving however, the reservation or reservations thereof should the same be renounced, discontinued, abandoned or the use thereof discontinued as prescribed by law by appropriate action of the proper officials having power or jurisdiction thereof.
