


RICHEY COVE SUBDIVISION FIRST ADDITION

AND BEING FURTHER DESCRIBED AS: From the center of Section 29, Township 258, Range 16E, Pasco County, Florida run N 90° 20' 45" W along the North-South centerline of said section 664.30 ft. for 0 Point of Beginning. Run thence N 89° 48' 25" W 735.91 ft. to the shores of Miller Bayou for a Point A. Return thence to the Point of Beginning and run S 0° 20' 45" W along said centerline of section 559.01 ft.; thence N 89° 55' 45" W 495 ft.; thence S 0° 20' 45" W 103.84 ft.; thence N 89° 55' 45" W 25 ft.; thence S 0° 20' 45" W 20 ft.; thence N 89° 55' 45" W 25 ft. to the shores of Miller Bayou. Thence thence thence to the shores of Miller Bayou in a Northwesterly direction 192.14 ft. to the aforesaid Point A
