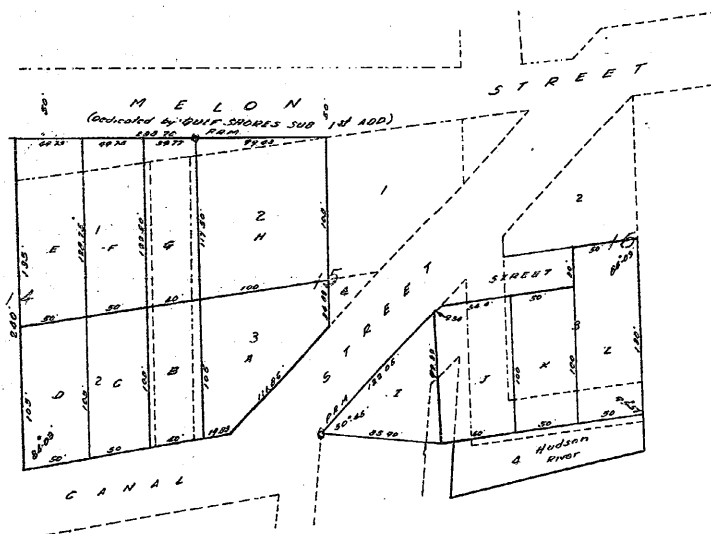


# RIVERSIDE SUBDIVISION



## DESCRIPTION

Subdivision of Lots 1 and 2, Block 14, Town of Hudson, as recorded in Plat Book 1, Page 40, Public Records of Pasco County, Florida, Lots 3 and 4, Block 15, Town of Hudson, Lot 8, Block 16, Town of Hudson, and that part of Lot 4, Block 15, Town of Hudson, lying South and East of Canal Street.

A triangular tract of land lying North of said Lot 1, Block 14, said Lot 2, Block 15, and the intervening street, and South of Canal Street to width. Dedicated by GULF SHORES SUB PL as recorded in Plat Book 5, Page 34, of the Public Records of Pasco County, Florida.

The intervening streets lying between said Lots 1 and 2, Block 14, and said Lots 2 and 3, Block 15, and between said Lot 3, Block 16, and said Lot 4, Block 15.
