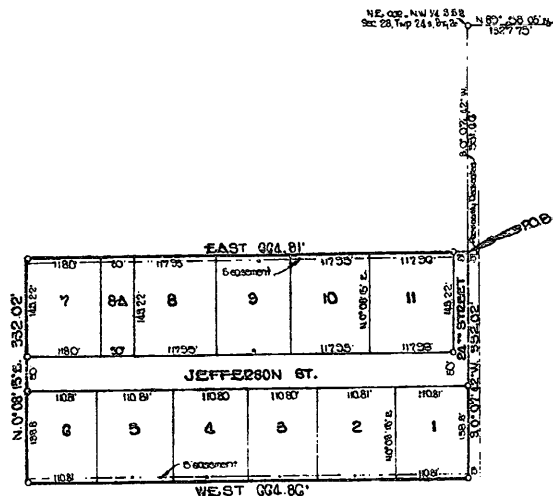


SKY LINE SUBDIVISION

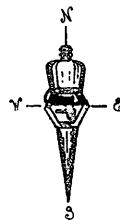

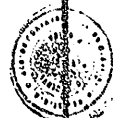
