

Commence at the Northwest Corner of the Southwest 1/4 of Section 15, Township 25S, Range 10E, Pasco County, Florida; thence run due East, 1,223.87 ft; thence run due South, 216.87 ft for a Point of Beginning; thence $87^{\circ}21'49''E$, 2600.0 ft; thence run $41^{\circ}03'11''E$, 100.0 ft; thence run $87^{\circ}21'49''E$, 70.55 ft; thence 1224.11 ft along the arc of a curve to the left, said curve having a radius of 882.43 ft and a chord of 121.11 ft which bears $N16^{\circ}38'07''E$, 60 ft. to the Point of Beginning. I hereby dedicate to the perpetual use of the public all roads, streets, alleys and other rights of way and all pores and recreation areas and all easements for utilities, drainage and other purposes and for all purposes incident thereto as shown and depicted hereon, reserving however, the reversion or reversions thereof should the same be renounced, declared, abandoned or the use thereof discontinued as prescribed by law by appropriate official action of the proper officials having charge or jurisdiction thereof.
