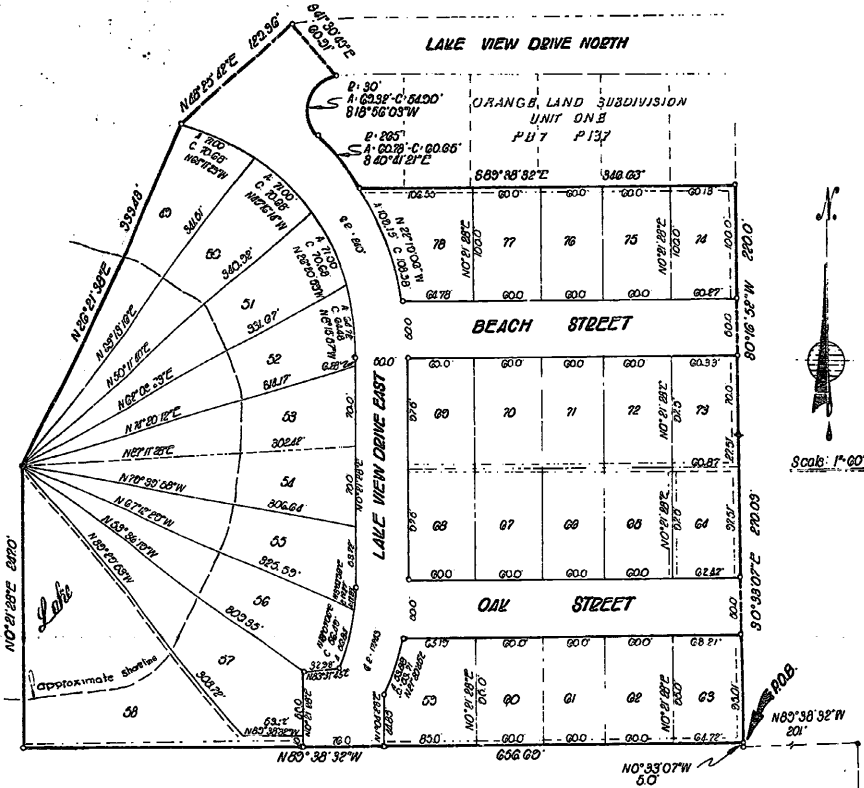


ORANGE LAND SUBDIVISION UNIT TWO

The undersigned owners of lands shown on this plat and described as being in Pasco County, Florida as follows:

Continued at the Southwest Corner of the Southwest 1/4 of Section 35, Township 26S, Range 10E, Pasco County, Florida; thence run along the East line of said Southwest 1/4, N0°10'38"E, 130.73 ft.; thence along the South line of the Northeast 1/4 of the Southwest 1/4 of said Section 35, N85°58'32"W, 201 ft.; thence N0°33'07"W, 5 ft. to a Point of Beginning, thence N85°58'32"W, 636.63 ft.; thence N0°27'28"E, 27 ft.; thence N26°27'38"E, 333.48 ft.; thence N42°25'42"E, 120.38 ft.; thence S41°30'45"E, 403 ft.; thence S32°32'N along the arc of a curve to the left, said curve having a radius of 30 ft. and a chord of 64.80 ft. which bears 81°58'03"W; thence S32°32'N along the arc of a curve to the right, said curve having a radius of 235 ft. and a chord of 62.66 ft. which bears S20°11'27"E; thence S20°38'32"E, 346.89 ft.; thence S0°16'02"W, 280 ft.; thence S0°33'07"E, 220.03 ft. to the Point of Beginning.

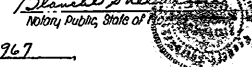
