


# BEACON SQUARE UNIT 14-A

Commence at the Northwest corner of the Southwest 1/4 of Section 24, Township 26S, Range 15E, Pasco County, Florida; thence run along the West line of the Southwest 1/4 of said Section 24, S0°10'36"W, 630.11'; thence S83°28'32"E, 440.27' to a Point of Beginning; thence continue S83°28'32"E, 476.07'; thence N85°23'42"E, 61.75'; thence N71°53'54"E, 287.17'; thence 232.12' along the arc of a curve to the right, said curve having a radius of 664.40' and a chord of 250.73' which bears S3°31'21"E; thence S0°00'29"W, 100.08'; thence N83°30'11"W, 66.11'; thence S88°56'42"W, 500.21'; thence N83°23'32"W, 855.81'; thence S0°10'03"W, 64.03'; thence N83°29'46"W, 400.311'; thence N0°10'10"E, 455.181' to the Point of Beginning.
