


GREEN KEY ESTATES

AND BEING FURTHER DESCRIBED AS: From the East 1/4 corner of Section 6, Township 26S, Range 16E, Pasco County, Florida, as a point of beginning, run S. 89° 52' 24" E. 782.33', thence by curve to the right, Radius, 125.11, arc, 115.70, ft. ch. N. 26° 09' 11" W. 118.81 ft. thence N. 10° 51' 50" W. 268.33 ft. thence S. 89° 52' 24" E. 118.43 ft. thence N. 53° 24' 50" W. 85. ft. thence by the following 3 courses along the waters of Oyster Bayou, N. 22° 26' 48" E. 71.53 ft. thence N. 8° 11' 05" W. 136.31 ft. thence N. 31° 51' 30" W. 171.02 ft. thence N. 39° 01' 19" E. 103.31 ft. thence S. 89° 52' 24" E. 782.33 ft. to the East line of said Sec. 6; thence S. 0° 04' 17" E. along said East line, 561.66 ft. to the R.O.B.
