


LAKWOOD UNIT

The undersigned owners and mortgagees of the lands shown on this plat and described as being in Pasco County, Florida, as follows:

Commence at the Northeast corner of the Northwest 1/4 of Section 3, Township 28S, Range 10E, Pasco County, Florida, thence run along the North line of said Section 3, N 80° 59' 27" W, 1,350.01 ft.; thence S 01° 51' 17" E, 10.11 ft. or Point of Beginning; thence continue S 01° 51' 17" W, 138.10 ft., thence S 01° 38' 53" W, 2,255.81 ft.; thence S 02° 27' 11" along the arc of a curve to the right, said curve having a radius of 150 ft. and a chord of 478 ft., which bears N 10° 43' 21" W; thence S 02° 27' 11" along the arc of a curve to the left, said curve having a radius of 100 ft. and a chord of 473 ft. which bears N 65° 32' 08" W; thence N 03° 03' 05" E, 2,730.81 ft.; thence S 00° 26' 00" E, 155 ft.; thence N 03° 55' 57" E, 140 ft.; thence 133.81 ft. along the arc of a curve to the left, said curve having a radius of 150 ft. and a chord of 332.81 ft. which bears N 26° 01' 20" W, thence S 02° 27' 11" along the arc of a curve to the right, said curve having a radius of 260.03 ft. and a chord of 66.03 ft. which bears N 26° 01' 25" W, thence N 03° 53' 27" E, 100.81 ft. to the Point of Beginning.
