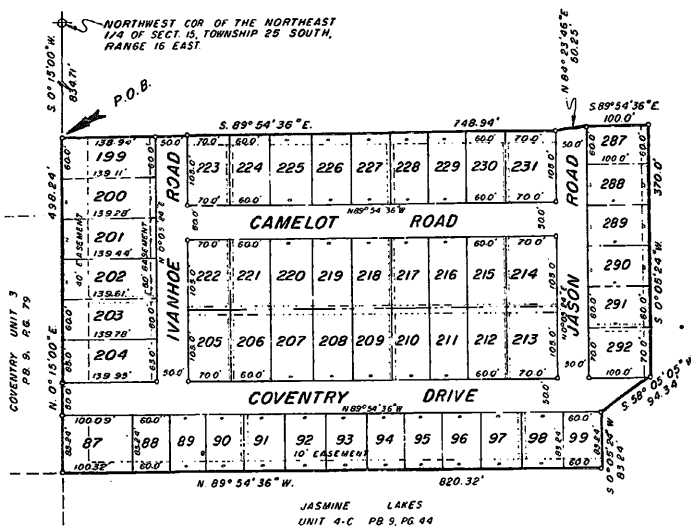


HOLIDAY HILL ESTATES UNIT ONE

FOR A POINT OF REFERENCE COMMENCE AT THE NORTHWEST CORNER OF THE NORTHEAST 1/4 OF SECTION 15, TOWNSHIP 25 SOUTH, RANGE 16 EAST, PASCO COUNTY, FLORIDA, THENCE RUN ALONG THE WEST BOUNDARY OF THE NORTHEAST 1/4 OF SAID SECTION 15, 5 0' 15' 00" W. 834.71 FEET FOR A POINT OF BEGINNING; THENCE RUN S. 89° 54' 36" E. 748.94 FEET; THENCE N. 84° 23' 46" E. 50.25 FEET; THENCE S. 89° 54' 36" E. 1000 FEET; THENCE S. 0° 05' 24" W. 370.0 FEET; THENCE S. 50° 05' 00" W. 94.34 FEET; THENCE S. 0° 05' 24" W. 83.4 FEET; THENCE N. 89° 54' 36" W. 820.32 FEET; THENCE N. 0° 15' 00" E. 498.24 FEET TO THE POINT OF BEGINNING. THE ABOVE DESCRIBED PROPERTY CONTAINS 121.1 ACRES, MORE OR LESS.
