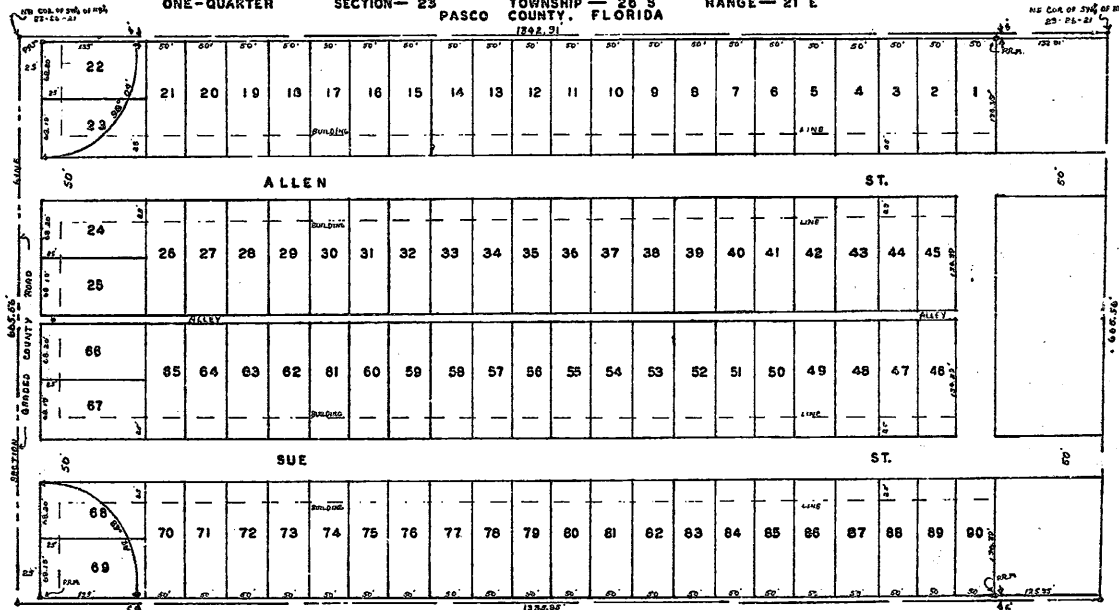


OAK RIDGE HEIGHTS
