

Thence N84° 46' 04" E. 733.22' thence S15° E. 360.4 ft. to a Point "A" on the shores of Moon Lake; return thence to the Point of Beginning, thence S55° 59' 36" E. 1366.35 ft., thence N84° 46' 04" E. 354.68 ft., thence by a curve to the right, radius .70 ft., Arc. 6580 ft., Chord. N80° 06' 58" W. 80.53 ft., thence S25° E. 180.68 ft., thence N65° E. 215.2 ft. to a point on the shores of Moon Lake. Hence from said point run along the shores of Moon Lake to Point "A".
