FOR A POINT OF REFERENCE COMMENCE AT THE SOUTHWEST CORNER OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 OF SAID SECTION 28, TOWNSHIP 25 SOUTH, RANGE 16 EAST AND RUN THENCE NORTH 89°58'10" WEST, ALONG THE SOUTH BOUNDARY OF THE NORTHWEST 1/4 OF SAID SECTION, 444.80 FEET; THENCE NORTH 0°27'05" EAST, 65.0 FEET FOR A POINT OF BEGINNING; FROM SAID POINT OF BEGINNING THENCE CONTINUE NORTH 0°27'05" EAST, 1260.32 FEET TO A POINT ON THE SOUTH BOUNDARY OF SAID TRACT 20; THENCE NORTH 89°58'14" WEST, ALONG THE SOUTH BOUNDARY OF SAID TRACT, 693.53 FEET TO THE SOUTHWEST CORNER OF SAID TRACT 20; THENCE NORTH 0°18'52" EAST, ALONG THE WEST BOUNDARY OF SAID TRACT, 330.62 FEET TO THE NORTHWEST CORNER OF SAID TRACT 20; THENCE SOUTH 89°59'52" EAST, ALONG THE NORTH BOUNDARY OF SAID TRACT, 1341.77 FEET TO THE NORTHWEST CORNER OF SAID TRACT 8 OF THE NORTHEAST 1/4; THENCE SOUTH 89°58'21" EAST, ALONG THE NORTH BOUNDARY OF SAID TRACT 8, 1324.23 FEET TO THE NORTHEAST CORNER OF SAID TRACT 8; THENCE SOUTH 0°08'29" WEST, 1604.37 FEET; THENCE NORTH 89°58'10" WEST, 894.90 FEET; THENCE NORTH 0°01'50" EAST, 20.0 FEET; THENCE NORTH 89°58'10" WEST, 450.0 FEET; THENCE SOUTH 0°01'50" WEST, 5.0 FEET; THENCE NORTH 89°58'10" WEST, 335.08 FEET TO THE POINT OF BEGINNING.
