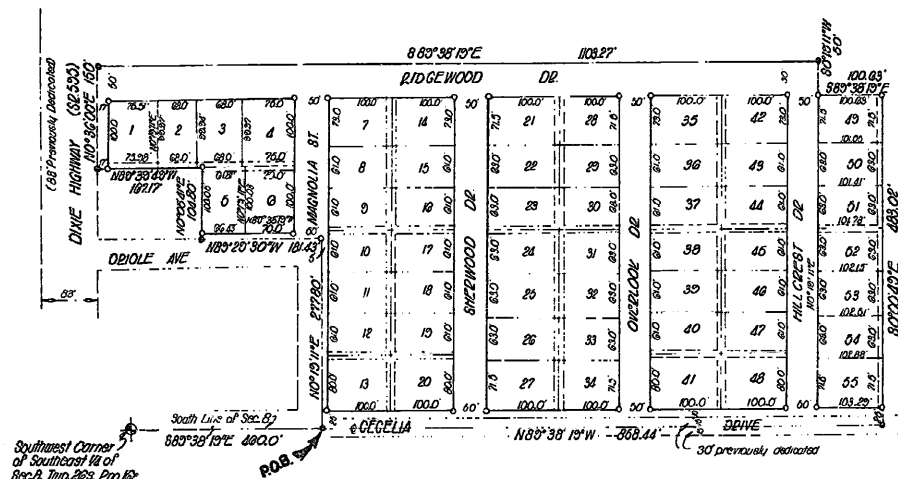


SILVER OAKS HILL
