



MOON LAKE UNIT TWENTY

BEING A SUBDIVISION OF A PORTION OF SECTION 28, TOWNSHIP 25 S, RANGE 17E, PASCO COUNTY, FLORIDA.

AND BEING FURTHER DESCRIBED AS: From the Southeast Corner of the Northeast 1/4 of Section 28, Township 25 S, Range 17E, Pasco County, Florida, for a Point of Beginning, Run thence N1°45'36"E 130.65R; thence N82°51'01"W 420.17R; thence N0°28'05"E 110R; thence N28°01'01"W 622.61R; thence by a curve to the left, radius 176 R, arc 181.64R, chord 152°45'01"W 172.95 R; thence N63°41'51"W 310.21R; thence N33°W 100.06 R; thence N57°E 101.18R; thence by a curve to the left, radius 190R, arc 103.43R, chord N16°30'E 102.93 R; thence N62°31'01"W 90R; thence by a curve to the right, radius 150 R, arc 74.97R, chord S10°30'W 132.04 R; thence S57°W 84.31R; thence N33°W 100R to the shores of Moon Lake for a Point A; thence thence to the East of Beginning and run N89°31'01"W 210.41R; thence S12°53'03"W 431.00R; thence S83°11'27"W 342.20 R; thence N40°03'01"W 512.40R; thence N10°51'32"E 182.80 R; thence by a curve to the left, radius 675 R, arc 510.80R, chord N87°55'16"E 590.20 R; thence N65°E 376.54 R; thence N12°W 200R to the shores of said Moon Lake; thence meander said shores in a Northeasterly direction to the abovesaid Point A.
