AULD LANE AND MADISON STREET AND ALSO THE POINT OF BEGINNING; THENCE RUN NORTH 69°48'53" WEST, 672.39 FEET ALONG THE SOUTHERLY BOUNDARY LINE OF SAID SECTION 20; SAID LINE
ALSO BEING THE CENTERLINE OF AULD LANE, THENCE NORTH 0°13'51" EAST, 203.71 FEET, THENCE NORTH 69°48'53" WEST, 203.71 FEET, THENCE NORTH 0°13'51" EAST, 129 FEET, THENCE NORTH
69°48'53" WEST, 105.00 FEET, THENCE SOUTH 0°13'48" WEST, 210.00 FEET TO THE SOUTHERLY BOUNDARY LINE OF SECTION 20 AND THE CENTERLINE OF SAID AULD LANE, THENCE NORTH
69°48'53" WEST, 335.55 FEET ALONG THE SOUTHERLY BOUNDARY LINE OF SECTION 20 AND THE CENTERLINE OF SAID AULD LANE, THENCE NORTH 0°13'48" EAST, 661.99 FEET ALONG THE EASTERLY
BOUNDARY LINE OF LA VILLA GARDENS PLAT BOOK 12 PAGE NUMBER 79, THENCE SOUTH 89°50'03" EAST, 1321.68 FEET TO THE EASTERLY BOUNDARY LINE OF SECTION 20 AND THE CENTERLINE OF
