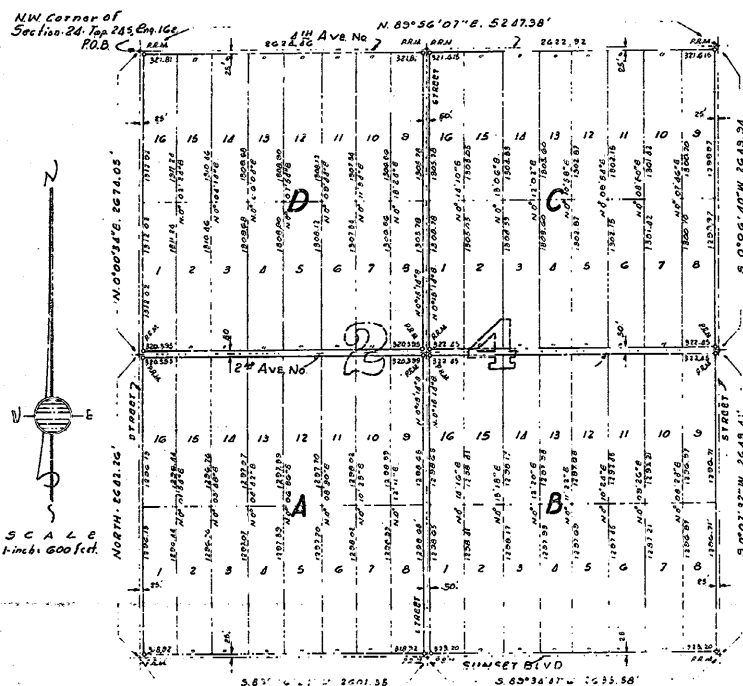


GULF COAST ACRES ADDITION
