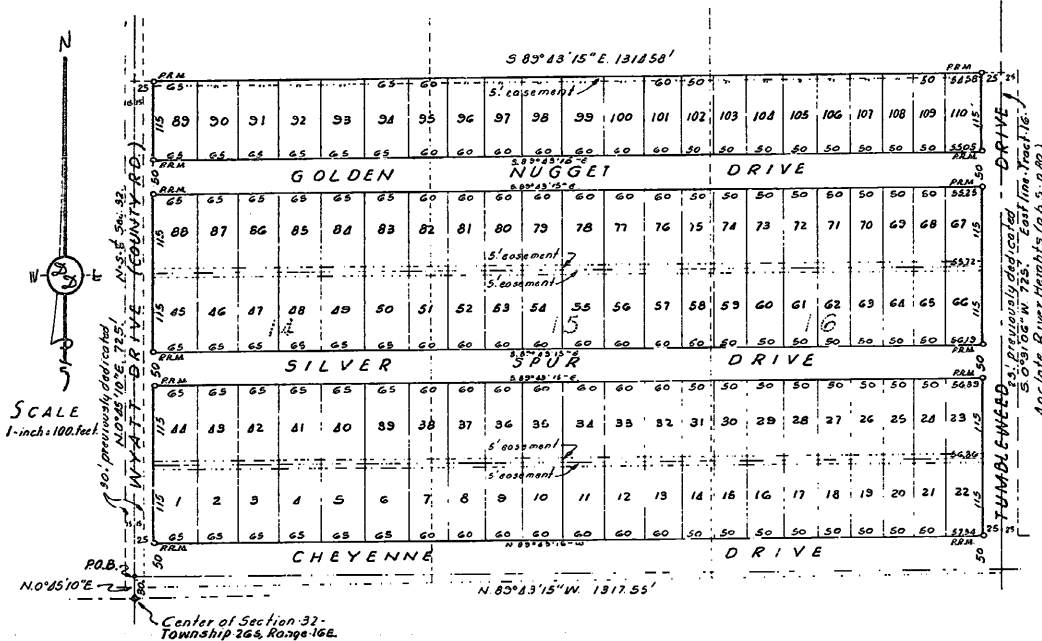


DODGE CITY

BEING A SUBDIVISION OF A PORTION OF TRACTS 14-15-16- OF THE TAMPA-TARPON-SPRINGS LAND COMPANY PLAT IN SECTION 32- TOWNSHIP 26S, RANGE 16E. AS RECORDED IN PLAT BOOK-1- PAGES-69-70- PASCO COUNTY PUBLIC RECORDS. PASCO COUNTY FLORIDA.



AND BEING FURTHER DESCRIBED AS: From the center of Section 32, Township 26S, Range 16E, run thence $N 0^{\circ} 45' 10'' E.$ along the North-South center line of said Section 32, 30.0 ft. for a point of beginning. Continue thence $N 0^{\circ} 45' 10'' E.$ along the said North-South center line of Section 32, 725.0 ft. thence $S 89^{\circ} 43' 15'' E. 1312.58'$ to the East line of Tract 16, of the Tampa-Tarpon Springs Land and Company Plat in Section 32, Township 26S, Range 16E, as recorded in plat book-1, pages-69-70, Pasco County Records; thence $S 89^{\circ} 43' 15'' E.$ along said East line, 725.0 ft. thence $N 83^{\circ} 48' 15'' W. 1317.55'$ to the point of beginning.
