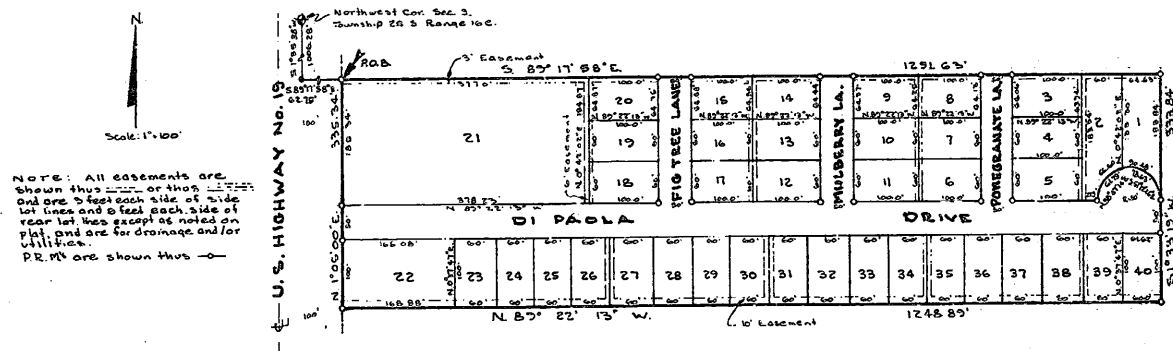


# DI PAOLA SUBDIVISION

Commence at the Northwest Corner of Section 3, Township 25 South, Range 16 East, Pasco County, Florida; thence run S 1° 35' 38" W, 1000.28 feet, thence S 89° 11' 05" E, 62.75 feet for a Point of Beginning, said point lying on the East Right-of-Way line of U.S. No. 19 as it is now constructed and also lying on the North line of said Tract 24; thence Continue S 89° 11' 55" E, 1251.63 feet; thence S 1° 35' 15" W, 333.84 feet; thence N 89° 23' 15" W, 1248.89 feet to the East Right-of-Way line of U.S. No. 19; thence along said Right-of-Way, N 1° 05' 00" E, 335.34 feet to the Point of Beginning.
