


JASMINE HEIGHTS UNIT ONE

AND BEING FURTHER DESCRIBED AS: From the Southwest Corner of Section 8, Township 26S, Range 16E, Pasco County, Florida, run N89°33'07"E along the South line of said Section 8, 660.32 ft. to point on the East Right-of-Way line of U.S. Highway #19 as now constructed; thence N24°03'23"E along said East Right-of-Way line 16.38 ft. to the Point of Beginning. Continue thence N24°03'23"E along said East Right-of-Way line 142.41 ft.; thence N80°20'45"E, 518.77 ft.; thence by a curve to the left, radius 750 ft., arc 222.97 ft., chord N77°57'45"E 822.15 ft.; thence 323°15'53"E 200.81 ft.; thence S19°36'56"E 149.03 ft.; thence S0°22'21"W 033 ft.; thence N89°37'30"W, 482 ft.; thence S71°32'40"W, 62.81 ft.; thence N89°37'30"W, 100 ft.; thence N0°22'21"E 704.88 ft.; thence N89°35'07"W 276.18 ft. to the Point of Beginning.
