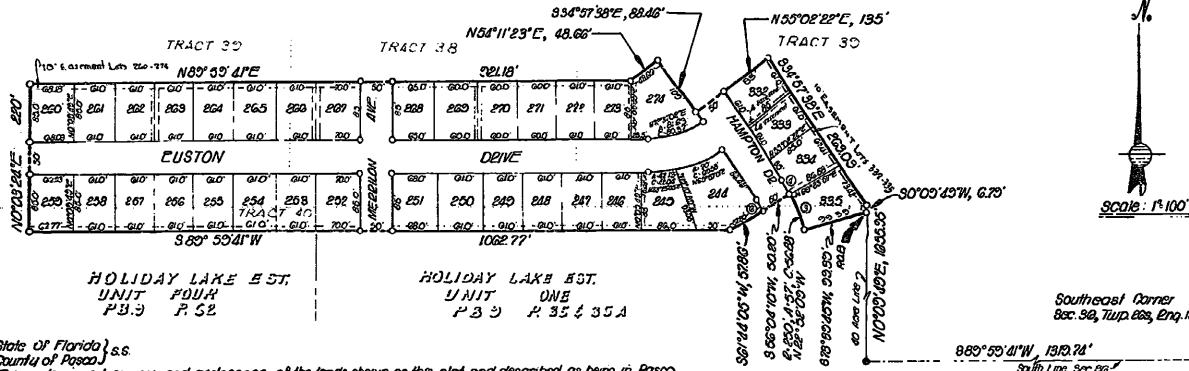


HOLIDAY LAKE ESTATES - UNIT FIVE
