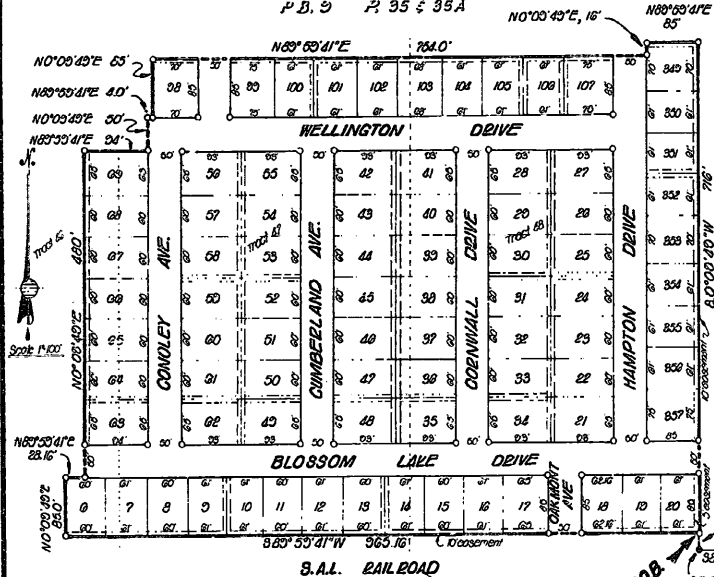


HOLIDAY LAKE ESTATES - UNIT TWO
