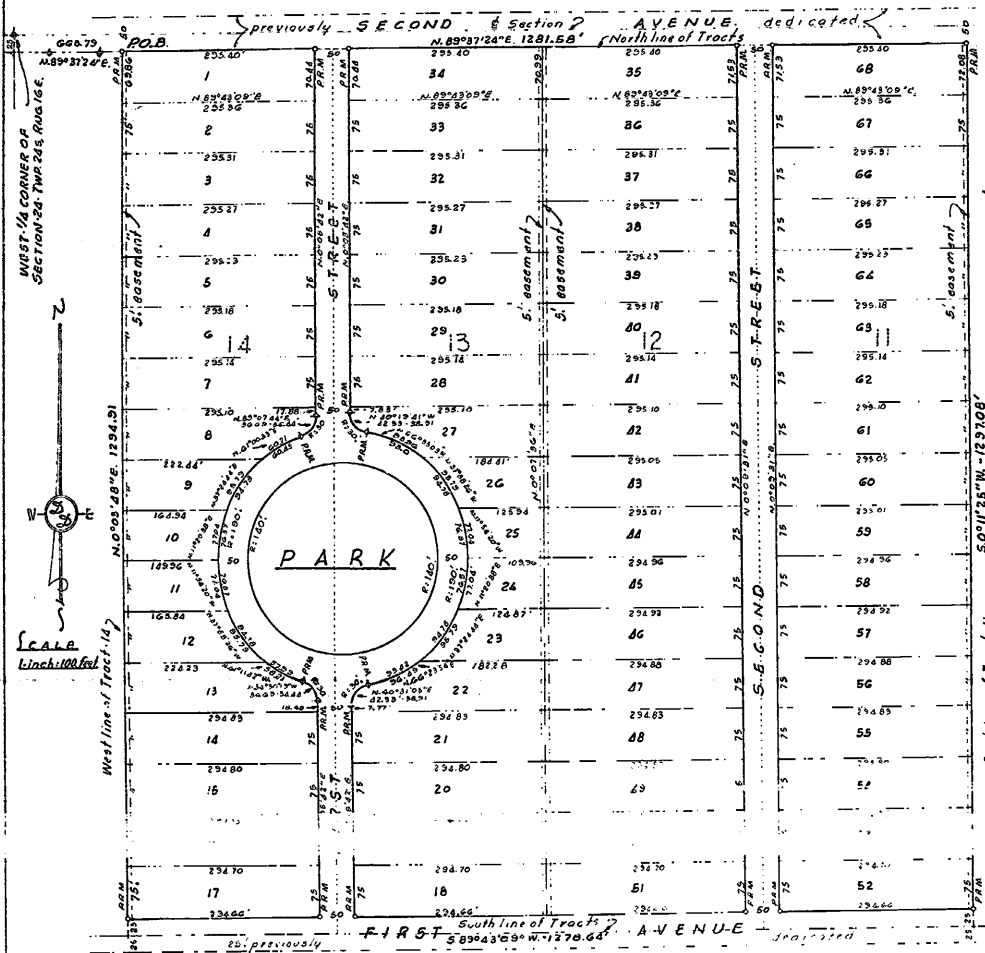


HUDSON ACRES

BEING A SUBDIVISION OF TRACTS 11-12-13 AND 14 - BLOCK "A" GULF COAST ACRES ADDITION AS RECORDED IN PLAT BOOK-5- PAGE-145- PASCO COUNTY RECORDS, AND BEING IN THE SOUTH 1/2 OF SECTION-24- TOWNSHIP-24S, RANGE-16E, PASCO COUNTY, FLORIDA.



AND BEING FURTHER DESCRIBED AS: From the West 1/4 corner of Section 24, Township 24S, Range 16E, Pasco County, Florida, run South along the West line of said Sec. 24, 25 ft. to an intersection with the North line of Tracts 11-12-13 and 14 - Block "A" Gulf Coast Acres Addition, as recorded in Plat Book-5- Page 145, Pasco County Records, thence N. 83° 37' 24" E. along the Westerly extension of the said North line of Tracts 11-12-13-14, 666.79 ft. to the Northwest corner of said Tract 14, for a point of beginning. Thence by the following four (4) courses along the North, East, South and West boundaries, respectively, of said Tracts 11-12-13-14, as one Tract, run N. 83° 37' 24" E. 1281.58 ft., thence S. 50° 11' 25" W. 1297.08 ft., thence S. 85° 43' 05" W. 1278.64 ft., thence N. 0° 03' 48" E. 1254.91 ft. to the P.O.B.
