Commence at the Northeast Corner of the Southeast 1/4 of Section 22, Township 25 South, Range 16 East, Pasco County, Florida; thence run along the East boundary line of said Section 22, South 0°02'37" West, 540.00 feet; thence North 89°58'51" West, 00°02'37" West, 747.87 feet for a Point of Beginning; thence continue along the East boundary line of said Section 22, South 0°02'37" West, 2700 feet; thence North 89°58'51" West, 550.00 feet; thence North 0°02'37" East, 174.35 feet; thence South 89°58'51" East, 500.00 feet; thence North 0°02'37" East, 65.00 feet; thence South 89°58'51" East, 84.80 feet; thence South 0°02'37" East, 64.00 feet; thence South 0°02'37" West, 50.00 feet; thence South 89°58'51" East, 483.00 feet; thence North 0°02'37" East, 65.00 feet; thence South 89°58'51" East, 84.80 feet to the Point of Beginning.

84.80 feet to be divided and subdivided as shown hereon and do hereby dedicate to the perpetual use of the public all roads, streets, alleys and other rights-of-way, and all parks and recreation areas and all easements for utilities, drainage and other purposes and for all purposes incident thereto as shown and depicted hereon, reserving however, the reversion or reversions thereof, should the same be renounced, disclaimed, abandoned, or the use thereof discontinued as prescribed by law by appropriate official action of the proper officials having charge or jurisdiction thereof, also reserving the right of ingress and egress over all rights-of-way and easements dedicated by this plat, in the event of repair or maintenance and easements dedicated by this plat, also reserving the right to construct and maintain water and sewer lines within all rights-of-way and easements dedicated by this plat, in the event of repair or maintenance causing damage to existing streets, owners agree to replace streets to prior condition within said damage area.

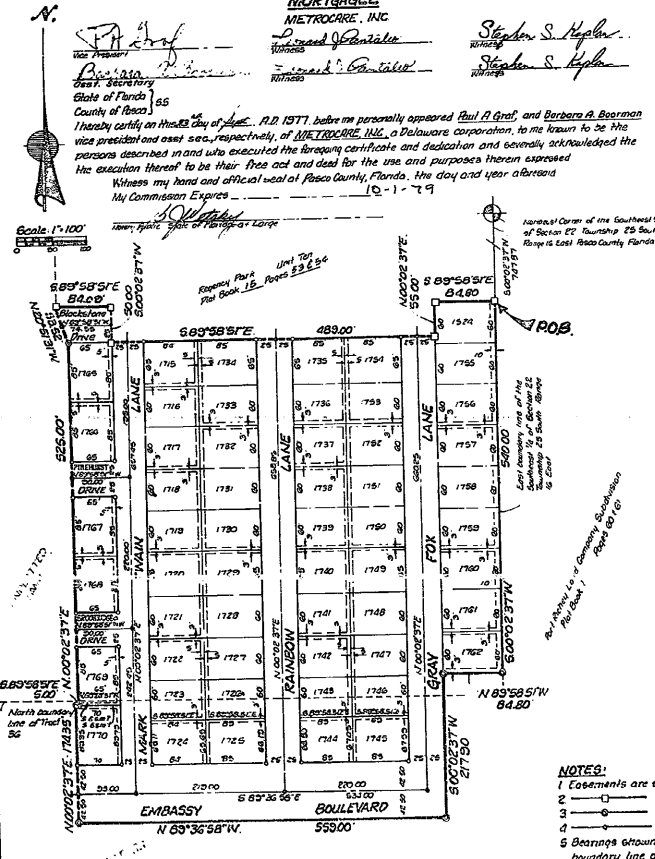
