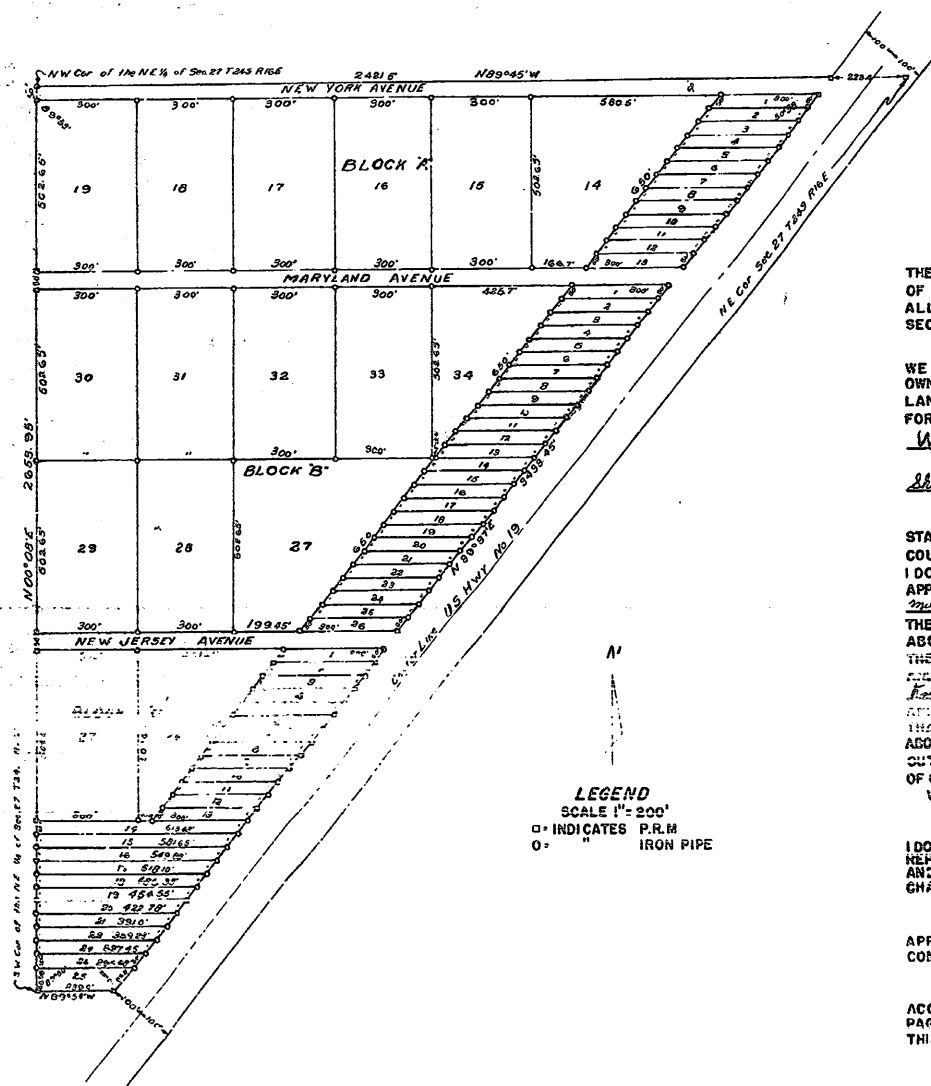


U.S. 19 NO. 9 ADD'N. PASCO COUNTY FLORIDA
