


**ADDITIONAL DEDICATION:**

**DESCRIPTION:**

Being a subdivision of lot 1, Block "C" of Te La Heights, Units 2&3 as shown on Plat recorded in Plat Book 3 on Page 67 of the Public Records of Pasco County, Florida and being more and better described as follows: Beginning at the S.W. Cor. of the N.E. 1/4 of Sec. 32-Twp. 25 So.-Rge. 16 E. and run N 0° 13' E - 88.0 ft. along the N.E. S. centerline of the said Sec. 32-25-16 to the shoreline of the Pithiochascootee River, thence meandering along this shoreline N 88° 32' 06" E - 55.31 ft.; thence N 85° 31' 49" E - 55.45 ft.; thence S 84° 43' 54" E - 55.50 ft.; thence N 69° 14' E - 59.17 ft.; thence N 77° 46' 03" E - 56.63 ft.; thence N 79° 43' 27" E - 37.27 ft.; thence N 69° 49' 24" E - 36.12 ft.; thence N 68° 45' 11" E - 33.96 ft.; thence N 64° 19' 25" E - 31.43 ft.; thence N 56° 54' 25" E - 36.46 ft. to the Northern Boundary of the said Lot 1; thence S 88° 32' 06" E - 167.00 ft.; thence S 8° 32' W - 90.3 ft.; thence S 2° 47' W - 91.8 ft. to an intersection with the E. & W. centerline of the said Sec. 32-25-16, thence West along the said E. & W. centerline 585.30 ft. to the P.O.B., all lying within the City Limits of Port Richey, Florida, and the west 10' of Lot 4, Block 1, Corrected Plat of Sunset Point, Plat Book 4, Page 37 of the Public Records of Pasco County, Florida.
