DISTANCE OF 1319.01 FEET; THENCE N 00° 45' 10" E., A DISTANCE OF 330.04 FEET;  
THENCE N 89° 50' 56" E., ALONG THE SOUTH BOUNDARY OF FOREST HILLS UNIT  
NO. 9, AS RECORDED IN PLAT BOOK 8 PAGE 135 OF THE PUBLIC RECORDS  
OF PASCO COUNTY, FLORIDA, BEING ALSO THE NORTH BOUNDARY OF THE SOUTHWEST

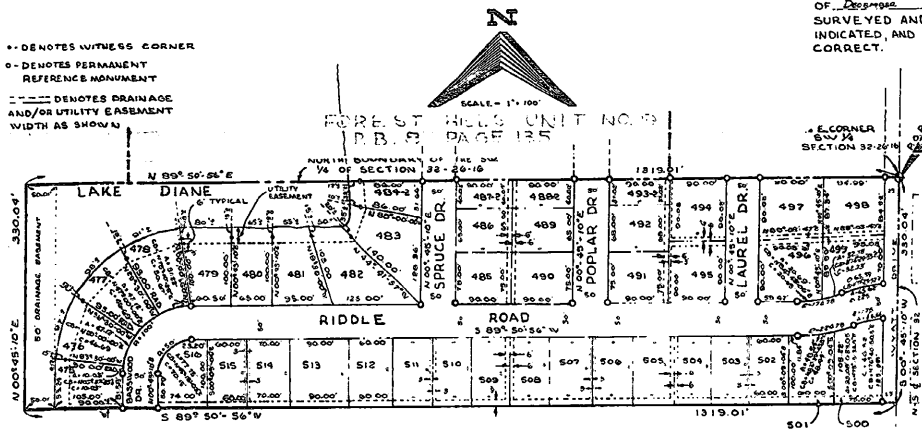
