


SIESTA TERRACE FIRST ADDITION

Run thence S0°42'00" W along the East Line of said Tract 18 1002.80 ft to the North line of the G.A.L. Railroad R/W; thence N0°20'42" W along said North line 444.6 ft to the West line of said Tract 18; thence N0°20'30" E along the said West line 1006.40 ft to the said North line of section; thence S83°42'00" E along said North Line of section 440.81 ft. to the Point of Beginning.
