1) N.43'00'00"W., 1248.50 feet; 2) N.14'50'55"W., 1149.77 feet to the Northwest 1/4 of Section 23; thence along the arc of a curve to the right having a radius of 120.00 feet and a central angle of 34°26'29" (chord bearing S.52°44'22"W., 71.05 feet) to a point of reverse curvature; 5) Southwesterly, 96.92 feet along the arc of a curve to the left having a radius of 120.00 feet and a central angle of 46°16'41" (chord bearing S.46°49'16"W., 94.31 feet) to the Northeasterly corner of TRACT "P", according to the plat of OAKSTEAD PARCEL 10 UNIT 2, as recorded in Plat Book 41, Pages 84 through 92, inclusive, Public Records of Pasco County, Florida; thence along the Northerly boundary of said TRACT "P", N.66°19'04"W., 60.00 feet to a point on a curve on the Easterly boundary of TRACT "B—6", according to said plat of OAKSTEAD PARCEL 10 UNIT 2; thence along said Easterly boundary of TRACT "B-6", the following four (4) courses: 1) Northeasterly, 145.39 feet along the arc of said curve to the right having a radius of 180.00 feet and a central angle of 46°16'41" (chord bearing N.46°49'16"E., 141.47 feet) to a point of reverse curvature; 2) Northeasterly, 36.07 feet along the arc of a curve to the left having a radius of 60.00 feet and a central angle of 34°26'29" (chord bearing N.52°44'22"E., 35.53 feet) to a point of tangency; 3) N.35°31'08"E., 195.63 feet to a point on a curve; 4) Northwesterly, 171.35 feet along the arc of a curve to the right having a radius of 525.00 feet and a central angle of 18°42'03" (chord bearing N.61°27'54"W., 170.59 feet); thence N.49°07'21"E., 40.21 feet; thence N.60°38'13"E., 45.91 feet; thence N.33°41'59"W., 14.95 feet; thence N.40°27'13"W., 33.90 feet; thence N.64°08'29"W., 33.00 feet; thence N.82°53'13"W., 31.66 feet; thence N.78°27'14"W., 32.97 feet to a point of curvature; thence Northwesterly, 32.52 feet along the arc of a curve to the right having a radius of 45.00 feet and a central angle of 41°24'32" (chord bearing N.57°44'58"W., 31.82 feet) to a point of tangency; thence N.37°02'42"W., 32.73 feet to a point of curvature; thence Northerly, 32.89 feet along the arc of a curve to the right having a radius of 45.00 feet and a central angle of 41°52'51" (chord bearing N.16°06'16"W., 32.17 feet) to a point of tangency; thence N.04°50'09"E., 31.36 feet; thence N.19°42'33"W., 1.71 feet; thence N.45°25'35"W., 16.44 feet to a point of curvature; thence Northwesterly, 25.21 feet along the arc of a curve to the right having a radius of 45.00 feet and a central angle of 32°06'07" (chord bearing N.29°22'32"W., 24.88 feet) to a point of tangency; thence N.13°19'28"W., 24.41 feet to a point of curvature; thence Northerly, 24.52 feet along the arc of a curve to the right having a radius of 45.00 feet and a central angle of 31°13'30" (chord bearing N.02°17'17"E., 24.22 feet) to a point of tangency; thence N.17°54'02"E., 21.21 feet; thence S.81°32'14"W., 42.54 feet; thence S.88°17'38"W., 55.63 feet; thence N.08°36'45"W., 19.27 feet to a point of curvature; thence Westerly, 82.54 feet along the arc of a curve to the right having a radius of 80.00 feet and a central angle of 59°06'45" (chord bearing N.69°03'23"W., 78.92 feet) to a point of tangency; thence N.39°30'00"W., 40.83 feet to a point on a curve; thence Southwesterly, 3.67 feet along the arc of a curve to the left having a radius of 25.00 feet and a central angle of 08°24'45" (chord bearing 5.57'49'51"W., 3.67 feet) to a point of cusp on the aforesaid Southerly right—of—way line of LAKE PATIENCE ROAD, as recorded in Official Record Book 5336, Page 1839, Public Records of Pasco County, Florida; thence along said Southerly right—of—way line the following two (2) courses: 1) Northeasterly, 497.58 feet along the arc of a curve to the left having a radius of 1530.00 feet and a central angle of 1838'01" bearing N.44'19'01"E., 495.39 feet) to a point of tangency; 2) N.35'00'00"E., 131.79 feet to the POINT OF BEGINNING.

Containing 119.515 acres, more or less.

Having caused said land to be divided and subdivided as shown hereon, Devco IV, L.L.C. ("Devco") and the Oakstead Community Development District"), as respective owners of the lands described above, do hereby grant to Pasco County, Florida (the "County") a perpetual easement over and across all street rights—of—way and the Emergency Access Easement as shown and depicted hereon for any and all governmental purposes including (without limitation) fire and police protection, and emergency medical services; and further do hereby dedicate to the perpetual use of the public and the County, all utility improvements and facilities, including but not limited to, water or sewer lines or pipes, fire hydrants, wells, lift station, pumping stations, buildings, sewage disposal plants, other utility plants and other appurtenant facilities lying within or upon the lands depicted on this plat and shown on the as-built plans filed with the County for such lands; and further do hereby grant the county a perpetual easement over and across the Drainage Easement and Wetland Conservation Easement areas for the purpose of maintaining or operating the drainage facilities situated thereon; and further do hereby reserve unto themselves, their respective heirs successors, assigns, or legal representatives, the right to construct, operate and maintain all utility improvements, or utilities and appurtenances lying within the lands depicted on this plat until such time as the operation and maintenance of said rights—of—way, improvements, facilities, and appurtenances is assumed by the County; and further do hereby reserve unto themselves, their respective heirs, successors, assigns, or legal representatives the title to any lands or improvements dedicated to the public or to the County, if for any reason such dedication shall be either voluntarily vacated, voided, or invalidated. It is the intention of the lands described above that the District shall construct, operate, and maintain (a) the street rights—of—way as shown and depicted hereon and (b) the drainage facilities and related improvements shown hereon. The District shall have the right at all times to enter upon the Drainage Easements and the Wetland Conservation Easements. and all other easement areas depicted hereon to accomplish such purposes.
